# What Legal Documents Do You Need to Remain in Control?



- Wills, Trusts, Powers of Attorney
- Most important documents—Power of Attorneys for Healthcare and Finances
  - Healthcare and end-of-life decisions
  - Financial management
    - Paying bills
    - Tax returns
    - Retirement administrator
    - Bank and investment accounts
- If you own real property in California You need a Trust!
  - Avoids Cost of Probate in time and money Statutory fees (\$\$\$\$)
  - Can enable advanced planning techniques for long term care planning



## Financial Powers of Attorney

- A Standard Statutory form is not enough
- Make sure your estate plan takes into account the possibility of needing to qualify for a government benefit
- Give your trusted agent the tools to take care of you
  - Who do you choose?
    - Oldest child? Most Responsible? More than one?
    - Are they equipped to do the job? Do they have the temperament? How much time does it take? Is their life stable?
  - Who can you trust?
    - Private Professional Fiduciary or Trust Officer at a bank?





#### Advanced Healthcare Directive


- Appoints an agent (and alternates) for Durable Power of Attorney for health care decisions
- Provides agent(s) with authority to access medical information and advocate on your behalf
- Statutory versus customized documents
  - Witnessing and notarization requirements
  - Inclusion of specific language to preserve long term care benefits
- Gives your agent control and direction over remains





#### **POLST**

- Physicians Order for Life Sustaining Treatment
  - For the seriously ill
  - Tells your exact wishes about certain medical treatments
  - A signed medical order that your health care team can act upon
  - Goes with you to your home, your hospital, or your long-term care facility
    - It goes where you go
  - It is a good idea that seriously ill people have both an Advance Directive and a POLST form





# Communicating Your Wishes

- Let agents and advocates know
- Provide copies of necessary documents
- Share important contact information
- Have regular conversations
- Share in a way that is comfortable for you





# **US Military Service Connection**



If you think you have a service-connected claim,

Talk with a VA-Accredited Attorney!

- For Parkinson's Disease to be considered presumptively caused by your service:
  - Must have served "in" Vietnam (boots on the ground) 02-28-61 thru 05-07-75, or
  - Prove one of the other types of exposure. There's a long list!
- Need help determining Exposure?
  - Free Agent Orange Registry health exam. Contact your local VA Environmental Health.
  - Not always thorough, but it gets you into health system faster.
